Topic: Implementation of Prohibition of the Development, Production, Stockpiling, and use of Chemical Weapons and on Their Destruction

Alarmed by the large stock piles of chemical weapons,

Deeply concerned by the devastating repercussions of the use of chemical weapons against civilians and/or military personnel,

Fully aware of the need for further development and funding of current chemical weapon organisations,

Aware of the progress achieved by past treaties and conventions aiming to accomplish the complete disarmament of all chemical weapons,

Understanding the production of chemical weapons is a varying process,

Noting with regret the excessive amounts of chemical weapon waste and residue discarded in the environment and thus disrupting the ecosystems,

Bearing in mind the millions of lives lost due to the use of chemical weapons throughout history,

In hopes of creating a prosperous chemical weapon-free world,

Seeking solutions towards a safer means of disposal of chemical weapons,

- 1. Requests safe disposal of chemical weapons of mass destruction;
- 2. Endorses monitoring of chemicals that could create chemical weapons;
- 3. Calls upon advanced monitoring systems with a strict export and transfer process for illegal and legal transfers of these materials;
- 4. Calls upon a world summit of experts to find new sustainable and safe ways to dispose of chemical weapons;

- 5. Proposes peaceful preparations between countries to safely dismantle and neutralize chemical weapons;
- 6. Recommends sharing detailed reports of nations' import and export of chemical weapons and dual use chemicals to the United Nations:
- 7. Encourages all member states to join the OPCW;
- 8. Further proclaims a greater fraction of the OPCW budget should be spent on the innovation of countering chemical weapons;
- 9. Raises awareness about the issue by educating civilians about the dangers of chemical weapons;
- 10. Further requests the possibility of recycling, reusing, and/or dismantling the components and by-products of chemical weapons for beneficial purposes
- 11. Encourages economic sanctions on countries that refuse to cooperate in decreasing their chemical weapon stockpiles;
- 12. Further recommends all member states to sign and ratify to the CWC;
- 13. Calls upon all member states to surrender their chemical weapons to the United Nations in order to safely dispose them;
- 14. Recommends peaceful solutions to countries that are threatened or attacked by chemical weapons;
- 15. Requests the right to search all government owned institutions or questionable sites with evidence of possible chemical weapon production;
