Fully Aware of the lack of global food security,

Taking into account that the FAO and WFP have both acknowledged that genetically modified organisms (GMOs) are safe,

Keeping in mind that GMOs are capable of growing in areas that do not generally support vegetation,

Bearing in mind that GMOs have been used by many countries,

Recognizing that farmers and countries need to be educated on the topic of GMOs and the effects of fertilizer and pesticides,

Acknowledging the fact that more testing is welcome,

1. Urging farmers to switch to organic farming in order to eliminate the harmful effects of pesticides and fertilizer;
2. Endorses the use of GMOs and organic farming;
3. Emphasizing the benefits of GMOs and organic farming such as yielding a larger crop which will lower global food prices;
4. Requests that countries around the world use GMOs to increase crops world wide;
5. Encourages countries to conduct research in order to promote and create technology that will create more arable land;
6. Approves the creation of organizations that will aid farmers and the process of switching to GMOs;
7. Reminds countries who import large quantities of food that their citizens will be able to buy more food because the food will have a lower price;
8. Affirms the beliefs that more jobs will be created;
9. Expresses its appreciation that more people in poverty will be able to obtain food.

Affirming our belief in organic farming and biofuels,

Keeping in mind the importance of educating farmers on organic practices,

Noting with regret the popularity of industrial farms and the monopolization of the market,

Contemplating the negative effects of clear-cutting and deforestation,

Taking into account the necessity of more research and the expansion of local farms,

Noting with deep concern the necessity to create more jobs,

Recognizing the need for the creation of organizations to aid people in this process,

Alarmed by the lack of accessible water and other resources,

1. Calls upon the use of organic farming and bio-fuels;
2. Endorses the creation of organizations that will:
 - a. Educate farmers on organic practices, and
 - b. Aid people in the switching to organic farming, and
 - c. Utilize the uncultivated lands, and
 - d Help support undeveloped countries and farmers;
3. Condemns the extreme use of industrial farming and the monopolization of the market;
4. Supports the liberalization of food trade;
5. Strongly condemns clear-cutting and deforestation;
6. Encourages further research to be conducted on this topic;
7. Draws attention to the expansion of local farms and markets;
8. Trusts that more jobs will be created which will stimulate the economy;
9. Approves the use of SARD (Sustainable Agriculture Rural Development);
10. Emphasizes regions to use local resources based on the ecological system on the basis of the agricultural practice;
11. Accepts the use of hydroponics.
