#### Rule of law resolution

#### **Co-sponsors:**

#### **Topic: Rule of Law**

The United Nations Legal SC. 1 committee, noting that not all nations obey the rule of law,

Taking notes that not all countries recognize the international court of justice,

Bearing in mind that the rule of law in necessary for the provision of society to become more civilized and modern,

Taking in to account that the rule of law started at 1688 B.C and it has lasted for 3600 years and it implemented can create peace worldwide,

- Requests and creates NGO's to aid nations in need of help and council on the rule of law
- Encourages an organization to offer optional help to countries in need of funds, providing training for civic education towards community members, civil servants and education on the importance of the rule of law and how to maintain it,
- Calls upon more developed and wealthy countries to provide funding and resources to less developed countries and enforce in order to help attain the rule of law
- Recommends collaboration and guidance from nations who have solved issues
  regarding the rule of law for nations who are developing their own system of
  rule of law,

- Proposes that the UN celebrates an international Summit that encourages
  collaborations of countries that support the development of the rule of law at
  national and international level.
- 6. Encourages the creation of a body that, if asked, will help countries in need to set up the judiciary independent of other legal bodies including the government.
- 7. The UN calls upon nations to attend a Summit that encourages the collaboration of countries that support the development of the rule of law at national and international level.
- 8. Calls upon European Nations to fund developing countries in need of financial aids due to an unstable economic state;
- 9. Draws the attention for NGO's to provide financial and tactical support in order to estimate and ameliorate development and is to be watched upon by the ICT;
- 10. Expresses its hope and strict laws against corruption and corrupt figures.
- 11. Encourages the creation of a UN organisation that would help developing countries and countries in war with their legal system;
- 12. Expresses its hope for voting procedure to be supervised by the UN authorities;
- 13. Emphasises the need of education of citizens about the rule of law in order for the citizens to understand that the rule of law was made for their safety, not to harm them;
- 14. Recommends that judges remain independent to maintain fairness in all courts;
- 15. Requests that all laws should be voted upon citizens;
- 16. Encourages international cooperation for fighting corruption by
  - a. Sharing information and evidence so as to cooperate in detecting corruption and punishing corrupt practises.
