Topic: Nuclear Disarmament

The General Assembly, alarmed that the current world is increasing expenditures in the development and the testing of nuclear weapons and less in the promotion of life and development,

Deeply concerned that in the current world certain countries have the capability of killing millions of innocent civilians in a matter of minutes,

Noting with satisfaction that multiple nuclear disarmament treaties including the Non-Proliferation Treaty (NPT) have been signed by the majority of member states and emphasizing the importance of this resolution,

Bearing in mind that nuclear waste and excess radiation is extremely harmful to the environment and could potentially destroy life as we know it,

Emphasizing the danger of nuclear weapons which if used could create a nuclear winter worse than the ice age,

Keeping in mind that a detonated nuclear bomb releases mass amounts of radiation that could affect the soil, making it impossible to grow consumer products,

- 1. Encourages member states neighboring nuclear armed countries to become nuclear weapon-free zones in the interest of peace;
- 2. Calls upon all member states to increase public awareness and knowledge on what nuclear weapons represent for human kind as well as the need for their total elimination;

- 3. Supports the promotion of nuclear energy with conjunction to the 2030 sustainable development goals;
- 4. Recommends that all countries possessing nuclear weapons reduce their nuclear arsenal by 5% annually and cease the production of nuclear weapons;
- 5. Recommends countries to stop using uranium for production of nuclear weapons and instead for alternative power sources;
- 6. Further requests complete transparency in all nuclear armed states pertaining to nuclear weapons;
- 7. Encourages the prevention of illegal sale and trafficking of nuclear weapons;
- 8. Confirms that nations will still be able to use and make nuclear powered energy;
- 9. Expresses its appreciation for all nations that follow this resolution.
