Topic: "Measures to Eliminate International Terrorism"

Alarmed by the number of civilian casualties,

Approving of past United Nations resolutions concerning anti-terrorism,

Believing that an education of citizens concerning the effects and significance of terrorism,

Guiding by the knowledge that violence is not the preferable solution for terrorism,

Realizing that terrorism is immensely significance,

Express the need for financial support,

- 1. Endorses a national and international plan to improve education;
 - a. Suggests that children between the ages of 5 to 16 attend a form of school
 - b. Recommends the teachings of different ethnicities in order to discourage racism
 - c. Recommends the teaching of why terrorism is unacceptable
- 2. Calls for member states to implement a strong police system;
 - a. Advises each country to maintain a strong, standing, police force
 - b. Calls upon the UN to provide peacekeepers for countries that cannot protect themselves
 - c. Allows police forces to surveil potential terrorists
- 3. Ensures that all media is equal and fair;
- 4. Affirms the need for member state participation in the fight against poverty;
 - a. Attempts to use economic measures to create jobs
- 5. Proclaims the need for a minimum prison sentence for a convicted terrorist;
- 6. Defines terrorism as an act of violence designed to create fear in the civilian population for personal/political gain;
- 7. Endorses strong and secure border checkpoints;
 - a. Advises all delegates to search for elicit weapons at borders
- 8. Emphasizing the need for the freezing of terrorist organizations' assets;

- a. Strongly condemns the action of assisting terrorist organizations in any way, shape, or form
- b. Calls for delegations to allocate more resources to organizations supporting the fight against terrorism
- 9. Expresses its hope that all nations cooperation in the struggle against intercontinental terrorism;
- 10. Declares accordingly in the case of self-defense that violence is used as a last resort in the struggle against terrorism;
- 11. Further requests for the UN to send peace keeping missions to affected countries to protect civilians and provide shelter;
- 12. Encourages member states to better integrate UN treaties into their way of life;
- 13. Encourages all nations to provide emotional and monetary support for the affected victims of terrorism;
- 14. Endorses the spreading of anti-terrorism propaganda on the internet;
- 15. Further invites nations to increase security around areas of historical and political significance;
- 16. Emphasizes the need for peace negotiations to be made with terrorist groups, if possible;
- 17. Formally requests funding on donations that would fund the education about terrorism for local citizens.
