**Topic:** "Measures to Eliminate International Terrorism"

Recognizing the fact that terrorism cruelly violates the universal declaration of human rights which designates every member of mankind,

Stressing the importance of the suppression of terrorism and the root causes,

Fully alarmed that terrorism affects the essential development for human society causing the disruption of treaties, plans, goals, targets, resolutions, propagandas, regimes, solutions, and etcetera,

Noting with satisfaction that following solutions in the operative clauses would eliminate sub regional, regional and international terrorism which not only does it accomplish the topic but has done further:

- 1. Approves sub regional, regional, and international police offered by developed countries, governmental organizations, international organizations, non-governmental organizations and et cetera;
- 2. Emphasizes to create a comprehensive and universal definition for terrorism and all its other related forms (for example: terrorist, terrorist attack, terrorist group, et cetera) in order to reduce confusion and any means that would slow down the process of the elimination of international terrorism;
- 3. Recommends moral and social education to be made compulsory for schools and recommends such education to be promoted through social media and other mediums to percent inequalities and disconnects between gender, skin color, country of origin, and ethnic groups;
- 4. Emphasizes governments to impose stricter gun laws with their citizen and also place even higher restrictions towards those citizens with criminal backgrounds;
- 5. Encourages operative clause 4 to be expanded to international law and suggestion composed by international organizations;

- 6. Requests to set up non-governmental, governmental and international organizations to combat terrorism and to protect those who are innocent from the danger, harm, and violence of the terrorist groups;
- 7. Supports the security council to place economic sanctions on corrupt members that do not try to eliminate terrorism or try to help terrorism;
- 8. Calls upon countries to strengthen their borders from terrorists with means for defending but still allowing normal passing of other people to cross the border or even welcoming those in need such as refuges with shelter, clothing, food and drinks and all other necessities for basic living;
- 9. Recommends governments to create fair laws to punish those who help terrorists and terrorism such as funding (monetary and non-monetary) and non-powering;
- 10. Emphasizes countries to develop religious studies and affirming the good of religion;
- 11. Further requests actions to solve poverty and inequities between races and ethnic groups must be taken;
- 12. Requests countries to stand with the UN and carry out all measures suggested by the UN;
- 13. Encourages inter-governmental exchange of information;
- 14. Encourages countries to cooperate with each other in the interest of the decision of this resolution;
- 15. Emphasizes that all countries should strengthen their militaries;
- 16. Notes to create a plan for non-governmental organizations to invite people who wish to become terrorists to see how society can help them and give them rightful place in society;
- 17. Supports governments to treat citizens fairly,
- 18. Takes note of the importance of human rights and takes note that all member states will protect these rights when combating terrorism;
- 19. Recommends operative clause 9 to act in care to protect countries' economies that rely on international banking;
- 20. Encourages cooperation with the International Monetary Fund through the Financial Action Task Force to counter black money and money laundering;
- 21. Recognizing the need for a stable government to be set up in an unstable zone once a terrorist group is obliterated;
- 22. Proclaims that there should be a NGO that allows potential terrorists to trade guns for a certain amount of food
- 23. Encourages countries to utilize a suitable amount of their Federal Budget to eradicate intercontinental and domestic terrorism, regarding and keeping in mind the clauses of this resolution.
