Topic: Financing Peacekeeping Missions - War & Disaster

The General Assembly, reminding all nations of the celebration of the 50th anniversary of the Universal Declaration of Human Rights, which recognizes the inherent dignity, equality and inalienable rights of all global citizens; guided by the principles of the United Nations Charter; recalling its past resolutions regarding the UNIFIL, MINUSTAH, UNMIK peacekeeping missions; alarmed by the child mortality rate; welcoming a new system for child protection in all training facilities, including all supplies needed for this to take place; urging the need for peacekeepers to become involved in helping children in war; taking into consideration costs that countries have to pay for energy; seeking renewable energy sources to reduce infrastructure costs and increase accessibility; guided by the increase of food and water-related disease; desiring new clean water sources and systems and availability in edible food through a sustainable source; alarmed by lack of funds for the UN peacekeeping missions; declaring a 15% increase in funds

from 1st world countries and select 2nd world countries, such as Japan, to help aid the UN peacekeeping forces; observing the smaller costs of naval transportation compared to air transportation; emphasizing the use of the DDR to clear all landmines and remnants of war; deeply concerned for the countries in need of peacekeeping operations; emphasizing the need for peacekeepers, military officers, medical personnel, and more advanced military training; declaring the need for citizens to learn and train in self-defense and basic medical operations; strongly suggesting the rebuilding of police stations and select infrastructures in post-war and disaster torn areas;

- 1. Approves the reduction of \$90,000,000* on the existing budget of \$926,733,100* directed to address UNIFIL, MINUSTAH, UNMIK peacekeeping missions in order to create the new budget for the upcoming operation;
- 2. Authorizes to cut \$20,000,000* from the UNIFIL peacekeeping mission;
 - i. \$10,000,000* from Military and Police personnel Cost,
 - ii. 10,000,000* from Naval Transportation;
- 3. Resolves to cut \$65,000,000* from the MINUSTAH peacekeeping mission;
 - i. \$60,000,000* from Military and Police Personnel costs,
 - ii. \$5,000,000* from Air Transportation;
- 4. Approves to cut \$5,000,000* from the UNMIK peacekeeping mission;

- i. \$5,000,000* from Civilian Personnel Costs;
- 5. Reaffirms that the total amount that will be taken away from the budget for UNIFIL, ⊠MINUSTAH and UNIMIK will be \$90,000,000*.
