Topic: “Rights of the Child”

Fully aware that the sole purpose of this resolution for the Social, Cultural, and Humanitarian Committee is to ensure that all children have access to their most important rights,

Emphasizing that the goal of this committee is to recognize inherent dignity, equality and inalienable rights of all global citizens,

Keeping in mind that the four basic rights that all children are born with: survival, participation, development, and protection,

Aware of the unsatisfying level of education the children receive in areas where child rights are neglected,

Recalling that children have indisputable rights to survival,

Having considered inhumane child labor, illegal working conditions, and the violation of child rights,

Believing that these problems can be solved, the General Assembly Third Committee puts forward these clauses to ensure child rights,

1. Endorses that all kids should have the indisputable right to education and properly be taught about their rights, and how to protect them;
2. Approves further construction of safe establishments including schools and orphanages to ensure a safe environment for all children, and providing a location free of abuse, neglect, oppression and others;
3. Reminds the fact that children need an adult or a guidance source in their young lives, children should not be living on their own with no sense of what is right or wrong;
4. Calls that children should be taken out of institutions which exploit child labor by laws, federal actions, restrictions, or investigations, children in impoverished living conditions should then be put into schools, and/or orphanages;
5. Recommends that schools provide support medical programs such as checkups or vaccines, and prevent malnutrition, schools can provide two meals a day to ensure the right to survival and health of children in all nations;
6. Notes that growth over a period of time in facilities such as schools, internet capable devices should be installed after a certain number of years to connect kids all around the world sponsored by the United States of America;
7. Approves that funds can be put into establishing and ensuring that the schools and projects to protect child's rights are created and shall be funded by businesses that will receive tax reductions, in addition, developed countries with over a GDP of \$100 billion USD should donate funds and would be paid back after 35 years .01% interest;

8. Recommends that nations slowly increase the minimum age for any kind of labor to conserve child rights;
9. Solemnly affirms that schools, safe houses, and orphanages do not discriminate against genders, religions, or race; and
10. Proclaims that nations should establish clean water sources as well as sanitary facilities for all children.
