Affirms that refugee children are a concern worldwide,

Deeply aware that we need to make changes in the way we approach the problem,

Alarmed by the fifteen million refugees worldwide that are affected by conflict,

Fully aware that refugees lack basic needs like food, water, education and shelter,

Takes note of the fact that over the past ten years, more than two million children have been killed,

Alarmed by the number of children injured or killed in armed conflicts,

1. Calls upon member states to fund shelter, basic education, food and water for refugee children;
2. Approves of providing safe homes for child refugees without parents or guardians;
3. Trusts families to take in refugees and their children;
4. Reminds countries that the “Free Rice” program is an efficient way to raise money for this cause;
5. Calls upon local communities to provide steady work for refugees to provide steady income;
6. Further recommends food and clothes drives to supply refugees with basic necessities;
7. Encourages NGOs to help raise money so refugee children can have an education;
8. Further requests that countries of the world conduct 5k runs to earn funds to supply food, clean water, shelter, healthcare and education to refugee children to be held on June 20, World Refugee Day;
9. Encourages countries who are able and have supplies to accept refugees worldwide;
10. Requests every country to have at least one emergency transit center to provide a safe place for refugees;
11. Encourages member states to provide choices for refugee children to return to their home country, stay in their new country or move to a third country;
12. Emphasizes the need for counseling to provide emotional support for child refugees;

## **Resolution UNHCR/ 1.1**

13. Recommends that refugee children attend a refugee school for one month before transferring to a regular school;
14. Takes note of the need to provide refugees with permanent homes;
15. Endorses the use of fliers to advertise these programs;
16. Solemnly affirms that the situation necessitates skilled doctors, teachers, and further security;
17. Expresses its hope for further fundraisers such as monthly drives, fairs, and community gardens;
18. Reminds participating nations to contribute to the best of their abilities financially through both governmental and private means;
19. Expresses its hope that refugees should be provided a chance to integrate into the society; and
20. Further requests a campaign to raise awareness of the refugee situation.
