Topic: "Eradicating of Forced Labor and Child Labor"

UNICEF, considering that the effective elimination of the worst forms of child labor is one of the world's most important issues facing the world,

Bearing in mind that child labor is one of the most dangerous weapons against children,

Deeply conscious that child labor must be abolished for the benefit of the world,

Expressing its commitment to help families suffering from crisis like disease or loss of house of shelter, which makes families force their children to work.

Aware if the work already done on this topic,

Therefore propose this resolution:

- 1. Further recommends that countries support the International Labor Organization and strongly commends countries that already support the ILO convention;
- 2. Encourages countries to set their next step goals to eliminating Child Labor nationally to protect the Rights of the Child;
- 3. Expresses its hope for enforcing strict laws and policies for eradicating child labor depending on its financial stability;
- 4. Calls upon children who have experienced child labor, encouraging them to speak up to journalists who can publicize it through media;

- 5. Congratulates countries that already fund poor families and request other countries to fund poor families if they have the economic strength;
- 6. Asks that countries raise taxes based on income to better fund education; health care, and general well being of the people;
- 7. Calls upon developed countries and banks to forget the debts that developing countries owe them, allowing them to improve economic conditions in the country so families don't have to resort to child labor;
- 8. Suggest the increased use of sponsored activities such walks for charity to raise money for the cause of child labor;
- 9. Strongly advises the increased funding of the IKEA foundation to help open up more jobs for women, so families will have reduced need make their children work;
- 10. Encourages the improvement of education with teacher training in developing countries;
- 11. Recommends the use of media and social networks campaigns to raise awareness for the problem of child labor;
- 12. Calls for the creation of an NGO that does investigative journalism around the world working to find and report on cases of child labor, to bring awareness, better inform people on the topic and its occurrence
- 13. Further reminds companies that child labor and human trafficking illegal and, more importantly, immoral;
- 14. Strongly recommends that developed countries help developing countries with technological development and provide access to well educated experts.
- 15. Encourages countries to fund NGO for creating universal education
- 16. Encourages the creation of an international child labor day;
- 17. Asks for nations to allow create regulated child labor for a maximum of 2 hours per day in safe conditions with a minimum age of 12, this is in recognition that many families find it necessary to make their children work to have enough money to survive;
- 18. Recommends the implementation of a Mid-day lunch scheme around the world;
- 19. Calls for the creation of database of companies and places that use child labor, to allow the tracking of these occurrences;

20. Encourages the use of "Child Labor Free" labels on products to help consumers make informed decisions.
