Topic: "Rights of the Child"

The General Assembly,

Bearing in mind that some parents can't or do not want to work and force their children to do so,

Noting that a child is physically and mentally immature and needs special care and protection before as well as after birth and also requires education that is free and compulsory as well as the right to play and recreate,

Taking into account that primarily poor families force their children into labor to increase the overall earnings of the family,

Noting with deep concern that child labor is detrimental to physical and physiological health of the child,

Taking into account the millions of children that are deeply influenced by their parents/guardians and affirming that some adults abuse or misuse that influence,

Deeply concerned by the fact that in countries like India which have developed cities have good medical facilities but not in the rural areas,

Bearing in mind that child rights are abused not only in developing countries but in developed countries as well,

Having studied that girls do not get equal opportunities as boys do,

Fully alarmed by the fact that the rights of the child is one of the few human rights that is violated immensely,

Bearing in mind that sufficient education and medical care is not available for most children,

- Encourages all countries to make laws to fine factories that hire children for labor, \$100,000 USD for every infringement;
- Orders each school to hire at least five security personnel to reduce violations of child rights in schools;
- 3. Authorizes the formation of a private organization that will be funded by investors and the above fines which will focus on medical care and education for children;
- 4. Draws the attention of the UN member states and all other countries that this organization will help in the educational and medical development of all countries of the world;
- Suggests that International Council of Child Rights (ICCR) to provide establishments from developed countries to intervene by stopping the exploitation of children by using them as recruits in the army;
- 6. Requests compulsory primary education and if possible secondary education as well along with free transportation to school;
- Trusts all countries to have no children under the age of 16 working for more than 2 hours a day, in safe working conditions and paid fairly;
- 8. Calls upon all countries to ban child marriage;
- 9. Encourages NGO's and governmental organizations to build orphanages for homeless and refugee children;
- 10. Requests government schools to distribute free uniforms, daily meals, books and stationery;

- 11. Supports the idea of unbiased treatment and creating equality between girls and boys by providing educational opportunities equally; and
- 12. Further invites all wealthy nations to provide funds to let children of poor families enjoy free primary education.
