Topic: Elimination of Racism

Emphasizing the need for the protection of the rights of all minorities, and keeping in mind that racism denies people of their human rights,

Observing the need to enforce the laws that protect those who are experiencing racial discrimination and enforce the laws that are currently being overlooked,

Alarmed by worldwide racial discrimination and workplace inequality,

Deeply concerned by the prevalence of racism in social media, and drawing attention to cyber discrimination on social media platforms,

Aware of the power social media has and wishing to use it to combat its negative effects,

Bearing in mind that half the world does not have internet connection and therefore do not have a platform to speak out about racism,

Acknowledging the violence and hate crimes caused by this problem, misinformation, and lack of anti-bias education,

Recognizing that some people are not racist but are not aware of all the effects of racism,

Reaffirming that racial intolerance has to be stopped,

1. Emphasises the need for member states to prosecute officers who commit police brutality and other racially rooted law enforcement incidents, further recommending ethics based police training;
2. Expresses its hope that countries will protect their citizens' rights by electing a diverse government;
3. Requests that all people are given equal opportunity in the workplace, and strongly encourages countries to enforce equality in the workplace and hiring process;
4. Encourages safe centers to be used for minorities to connect with each other globally;
5. Endorses the work of global protest movements such as BLM;
6. Further emphasizes the right of indigenous people, refugees and immigrants to practice their culture, language and religion;
7. Encourages social media sites to improve their rules on racism by using fact checkers to notify users of problematic websites;
8. Proposes that ambassadors or delegates from countries take an online course and then teach people in their country about how to react and stand up to racism, and hate speech;
9. Recommends schools implement ethics and race courses once a week from 1st to 8th grade;

10. Encourages countries to organise and fund anti-bias campaigns and NGOs such as BPERD (Building of Prevention on Elimination of Racial Discrimination) according to the needs of their countries such as by using public service announcements such as posters, leaflets, flyers, and billboards to spread awareness about racism and how it affects everyone in their daily lives.
