Topic: Protection of global climate for present and future generations of humankind

Recognizing the financial limitations of developing countries and the cost of converting to renewable energy,

Deeply alarmed by the current situation and lack of knowledge surrounding the dangers that climate change presents, and how fossil fuels contribute to that,

Taking into consideration the alternate sources of energy, all of which would help us in the battle against climate change,

Reminding countries that methods for lessening climate change already exist, including renewable energy sources however they need to be utilized properly,

Renewable Energy Solutions

- 1. Encourages the planting of more flora in populated areas to increase natural carbon reduction;
- 2. Further requests the improvement of production and affordability of electric vehicles;
- 3. Recommends the use of more recyclable items in restaurants and fast-food chains and encourages use of strict recycling guidelines;
- 4. Strongly advises countries to set aside funding for the construction of renewable energy sources such as solar power, wind power, hydrothermal, and nuclear power to counteract the growing threat of climate change;

Financial Solutions

- 5. Encourages developed countries to collaborate with and financially support countries impacted by climate change to help them rebuild and switch to renewable energy;
- 6. Calls upon countries to respect any agreements made especially ones regarding climate change, since this issue is very severe, and we need to put our best effort into solving it;
- 7. Requests that countries shift a portion of taxes from renewable energy to fossil fuels and building energy efficient buildings to encourage the population to minimize fossil fuel usage as well as offering businesses incentives to lower carbon emissions;

Education and Awareness Solutions

- 8. Calls upon social media influencers, schools, and websites to educate people and spread awareness on the issue and effects of climate change in order to implement solutions such as holding events and programs;
- 9. Notes the need for funding to help implement solutions;

Carbon Emissions Reduction Solutions

- 10. Endorses designing structures for the purpose of withstanding increasingly deadly natural disasters created by climate change;
- 11. Underlines the global crisis that is climate change and the importance of putting our best effort to save our world;
- 12. Advises the use of carbon capture systems to lessen the effects of global warming;
- 13. Recommends researching substitutes for construction materials such as wood, concrete, and steel to reduce deforestation and carbon emissions.
