### Topic: Leaving No One Behind

Alarmed by the overwhelming amount of people in poverty,

Believing that all people should relieve fundamental resources,

Fully aware that many workplaces don't yet provide their employees with free healthcare,

Deeply concerned that education systems are not getting the funding they need to properly train staff members,

Deeply concerned by the lack of funding, affordability, accessibility and staffing/qualified staff in healthcare facilities,

Taking into consideration that discrimination leads to people not receiving proper healthcare,

Recognizing the need to have better education opportunities for vulnerable communities,

Deeply concerned by the lack of attendance in schools located in low income areas,

### Education and Support for People in Need

1. Calls upon member states to provide funding for financially unstable education systems in other member states;
2. Encourages member states to provide funding to diminish poverty worldwide;
3. Recommends that schools provide free nutritious meals to increase attendance;

4. Further requests that member states provide free or affordable child care for their impoverished citizens;
5. Urges member states to further develop online platforms for their students' scholastic growth;
6. Strongly encourages creating donation centers in low income areas to provide resources for the community;

### **Proper Healthcare for Everyone**

7. Encourages less expensive healthcare and medicine, which, in turn, would make healthcare more accessible;
8. Recognizes the positive impact of an international fund for improving healthcare systems;
9. Emphasizing the need for better training and more training facilities for healthcare workers in order to access better medical care;
10. Requests the education of people on medical biases to prevent malpractice;

### **Funding and Jobs**

11. Suggests that there be tax transparency to further inform citizens about where their tax money is going to, as it can be used in more effective ways;
12. Calls upon workplaces to ensure equal opportunities for all genders, races, sexes, identities, visual appearances, etc;
13. Consider increasing job opportunities for impoverished people;
14. Further requests to make jobs and have improved health benefits;

### **Improved Fundamental Needs**

15. Calls upon schools and education systems to provide free nutritious food for those in need;
16. Recommends all member states to increase the minimum wage to a humane amount;
17. Urges the development of accessible and affordable housing such as community shelters and mobile homes;
18. Encourages member states to establish programs that provide clean water and jobs to impoverished communities;
19. Takes note, providing people with fundamental resources would have a positive impact on their overall wellbeing.
