## Topic: Protection of global climate for present and future generations of humankind

Fully aware that green jobs help the environment and help provide jobs,

Taking into consideration green agriculture helps preserve water,

Noting with regret that the sea life is affected by non-biodegradable materials in oceans,

Keeping in mind that not all member state can afford renewable energy and acknowledging member states' efforts to create long term low carbon development strategies,

Taking note of the green house gas and fossil fuel emissions and recognizing the effects it has on our planet,

Noting with regret that many people do not know about climate change,

Fully believing that the Paris Agreement could mitigate climate change,

- I. Expresses its appreciation for more training for green jobs;
- 2. Requests people to plant trees, and use foods scraps for fertilizer to avoid causing deforestation;

- 3. Recommends better education to farmers about sustainable agriculture and sustainable alternatives to pesticides to avoid high pollution levels;
- 4. Calls upon member states to create animal protection zones and laws around protected areas;
- 5. Further recommends a better understanding of deforestation's affects while condemning the acts of the groups causing deforestation;
- 6. Recommends governments to tax high pollution producing companies;
- Approves of teaching youth to use their own biodegradable products due to the effects of climate change;
- 8. Encourages people to do more recycling work through the use of biodegradable materials;
- Encourages companies to lower the prices of renewable energy sources so that developing member states can afford it;
- 10. Requests that a treaty to reach net zero emissions by 2050 be made;
- 11. Calls upon member states that can afford renewable energy to start using it;
- Encourage member states who work and rely on nonrenewable energy sources to work in collaboration with non governmental organizations who help countries in need of renewable energy sources;
- Recommends increasing the use of alternative energy sources such as wind, hydro and solar power;
- 14. Further recommends that subsidies on oil, coal and gas production should be mitigated until it can be completely stopped;
- 15. Encourages schools to hold seminars for the children across the world to educate them about climate change;
- 16. Recommends people to spread information about climate change across social media platforms;
- 17. Invites governments of member states to hold meetings with their citizens to educate them and make them aware of how they can help reduce climate change;
- 18. Affirms the start of transmitting knowledge about climate change and its effects throughout news from governments around the world.
