**Topic: Impact of the Ukraine-Russia conflict on global food security and related matters**

Alarmed by the Russian Intervention in Ukraine and its impact on global food security,

Deeply disturbed by the fact that at least 14 million people have been displaced and over 38 thousand have been killed due to this conflict,

Noting with concern that wheat exports by the Russian Federation and Ukraine accounted for about 30% of the global food market, making them the most prominent players in the global food trade,

Realizing that due to the recent situation of warfare in Ukraine the countries that rely on the Russian Federation and Ukraine are now food insecure,

#### **Trading, distributing and exporting agricultural products**

1. Strongly recommends the use of food services internationally along with implementing the usage of greenhouses and hydroponic agriculture;
2. Endorses treaties between conflicting nations regarding the exportation of food;

3. Requests the extension of the Black Sea Grain Initiative to be renewed semi-annually;

### **Re-establishing global food security by stopping the Russian Intervention through economic sanctions**

4. Strongly advises countries to find alternative fuel suppliers to decrease the Russian Federation's presence on the fuel market, effectively creating a dip in Russia's economy;
5. Encourages countries that haven't put economic sanctions on Russia to do so in order to limit Russian war capacity;
6. Further resolves to reinforce security measures in the Panama Canal to find any nuclear weapons or biological warfare devices carried by Russian, flagged ships and restrain them from crossing;

### **How to improve farming and food security through technological development**

7. Encourages countries to produce their own agricultural products and source their food from different suppliers so they stay food independent at all times, including times of crisis;
8. Advises countries to boost production of staple and essential goods to promote self-sufficiency;
9. Takes note of the benefits of the new agricultural methods that will positively impact global health;
10. Invites countries to implement cleaner farming by reducing the usage of chemical fertilizer;

### **Humanitarian aid**

11. Urges economically developed member states of the United Nations to provide peacekeepers to protect transportation of goods such as grain deposits that will help developing countries;
12. Calls upon countries to provide more jobs in the agricultural industry to refugees;
13. Encourages countries to create programs to help those affected by agricultural issues and humanitarian crises;
14. Expresses its appreciation to countries and organizations involved in improving humanitarian aid and cleaner farming.
