Topic: Rights of the Child

Recognizing international cooperation will significantly assist in solving this issue and promoting worldwide child rights,

Acknowledging that all children have a right to quality education,

Emphasizing the importance of a child's wellbeing and health,

Recognizing the entry in force of the convention of the rights of the child and reminding the commitment of state parties to articles 2, 12, 13, 19, 23, and 33-37 regarding the abuse and injustices against children,

Fully alarmed by the multitude of children facing severe acts of mistreatment, marginalization, and blatant disregard of children's rights,

Education and Well-Being of Children

- 1. Endorses the creation of the international children's rights fund that support children's education by organizing the nations towards specific areas of fund mobilization given each country's situations for providing social protection and living condition resources;
- 2. Urges member states to implement national policies that involve public authorities in order to spread awareness of the violations of children's rights;
- 3. Further encourages member states that have not already ratified the UNCRC to ratify it and deplores member states that continue to deny children their rights;
- 4. Notes with satisfaction all international and national efforts and actions which have been and continue to be taken to support children's wellbeing;
- 5. Recommends NGOs, international organizations, and member states to provide more resources to improve children's wellbeing and education by building more schools, waterwalls, improving the recruitment of teachers and staff, etc.;

External Involvement and the Achievement of Worldwide Child's Rights by International cooperation

- 6. Calls upon NGOs, branches of the UN, and international programs to research and raise awareness of children's rights, economic status in rural areas, and child labor through social media campaigns of annual HRC meetings in order to assist them;
- 7. Advises the UN and the UNHRC to create annual summits about targeted issues related to children's rights to hold nations accountable and assess efficient and specific targets by 2030;
- 8. Strongly encourages sanctions to be applied appropriately on developed countries which significantly participate in child rights violations, including child labor. Equally, incentives including funds should be offered to developing countries from developed countries to assist the implementation of the UNCRC;
- 9. Requests governmental and non-governmental organizations to take note of the communities who are further troubled by the implementation of the UNCRC and provide funding/aid to them;
- 10. Further invites branches of UNICEF to be created, focusing on specific issues on the rights of the child, including increasing technology in developing countries, resiling in increasing access to education and allowing children to take advantage of optional

protocol 3 of the UNCRC (online reporting system) and scheduled inspectors by rapporteurs of both working conditions for children and law officials;

Abuse and Injustices for Children

- II. Encourages stakeholders to ratify and acknowledge the four optional protocols of the UNCRC, specifically, optional protocol to the Convention on the Rights of the Child on the involvement of children in armed conflict and optional protocol to the Convention on the Rights of the Child on the sale of children, child prostitution and child pornography for child labor;
- 12. Emphasizes the improvement of working conditions on farms and industrial areas to provide employment for workers in need and eliminate obstacles to the establishment and pursuit and growth of lawful activities to promote the role in economic and social development;
- 13. Calls upon governments to effectively monitor children living in abusive and neglected environment by establishing a child protection mechanism and increasing the education of parents and communities;
- 14. Further suggests stakeholders to commit and develop action plans in order to prevent the recruitment and use of children in armed conflicts by assembling framework within armed forces;
- 15. Strongly recommends governments to review their security and national policies for girls and young women dealing with escalating abuse and exploitation such as child marriage and sexual trafficking;
- 16. Further advises stakeholders to adopt child sensitive frameworks and procedures to guarantee access to justice for children by implementing legal representation, assistance, and one stop centers which allow children to make individual complaints;
- 17. Fully appreciates the involvement of member states and NGOs to access awareness and education campaigns about the abandonment of harmful practices such as female genitalia mutilation and killing in the name of honor;

Social Injustice For Marginalized Children

18. Encourages member states to create public centers for children, especially immigrants and refugees, where they receive free healthcare and other necessities;

- 19. Calls upon governments to establish routine checkups in school to ensure a decrease in discrimination by establishing teacher's workshops in each school where they learn strategies to combat any form of discrimination;
- 20. Recommends the creation of campaigns in rural and isolated areas where volunteers and state personal can provide children with basic human needs and ensure their security and health;
- 21. Strongly deplores any acts of abuse and thus encourages implementing accessible mental healthcare for schools and public organizations, especially marginalized children and victims of abuse;
- 22. Suggests that member states support any NGOs or other programs that are working towards raising awareness of any form of discrimination against children.
