

# **Resolution Human Rights Council/2.1**

## Human Rights Council Committee

#### **Topic: Rights of the Child**

Deeply disturbed by the amount of children involved in child labour,

Convinced that under aged marriage is a problem,

Fully aware of the children in need of a sustainable shelter,

Deeply concerned about children with disabilities in need of extra help,

Taking note of the poor conditions in orphanages,

Alarmed by the amount of children that are not respected by their gender,

Aware of the amount of children who do not have proper education,

Deeply concerned that children living in warzones are at risk of death, harm or losing their homes,

Alarmed by the fact of how many homeless there are and that children are being abused and killed,

#### **Conditions of the Child**

I. Requests child laborers and adults to realize that children are human beings, not objects;

- 2. Further invites countries to not partake in child labour and child marriage;
- 3. Calls upon the government to provide money to families in debt so children do not have to work;
- 4. Draws the attention to neglected and abused children and provide a safe environment away from their child labour or abusive people;
- 5. Supports spreading awareness of sexually-harassed children;

### Security and Healthcare

- 6. Calls upon the government to construct more sustainable shelters for children in poverty;
- 7. Draws the attention to construct more schools for children with disabilities;
- 8. Endorses adding more rooms, better food and sanitation to orphanages;
- 9. Requests governments to donate and create food banks for children in poverty;

#### **Child Respect and Mental Health**

- Calls upon the United Nations to hold a summit so all member states can come together to solve this important crisis;
- II. Encourages governments to provide free education for the lower class;
- 12. Authorizes that children should have an annual free check up for mental health diseases and other healthcare units;
- Requests that there is an annual child festival where children celebrate being themselves and expressing their feelings as children;
- 14. Supports the children who are living in poverty by donating money to kids in need;

#### **Child Protection**

- 15. Draws attention to protect children that go through abuse;
- Recommends constructing safe buildings to reduce the amount of deaths of children in war zones;
- 17. Authorizes the use of vaccines to protect and prevent diseases common with children.
