#### **Topic: Rights of the Child**

Fully aware that many children around the world do not have access to quality healthcare,

Noting with regret that children from all around the world are victims of malicious forms of abuse,

Alarmed by the fact that many children do not have access to birth registration,

Deeply concerned at the lack of access to quality education due to a plethora of factors,

Alarmed by the amount of children involved in human trafficking,

Noting with regret that adult conflict can have negative effects on children,

Having studied the 1990 CRC,

Alarmed that I billion people ages 2-17 are estimated to have experienced physical, sexual, and emotional violence,

#### **Mental and Physical Health**

- I. Acknowledges mental harm before it damages physical health;
- 2. Affirms the need for governments and organizations to devote money towards providing food for malnourished children;
- 3. Encourages the creation of children's shelters to provide homeless children food, water, and a place to sleep so that they aren't unsupervised;

#### Wellbeing and education

- 4. Calls upon governments to develop affordable transportation networks in order to grant access to adequate education and registration facilities;
- 5. Recognizes the need for safe and qualified teachers to create a more positive learning experience;
- 6. Emphasizes the need to financially support families that struggle to afford adequate education;
- 7. Confirms that education is essential to higher paying jobs and having a secure financial future;
- 8. Proclaims that education is the first step to ending the cycle of poverty and ensuring the wellbeing of children now and in the future;

### **Protection and Security**

- 9. Urges for more accessible and in depth background checks;
- Requests that there be a universal age for military drafting so that children aren't involved in armed conflicts;
- Calls for spontaneous annual evaluations in circumstances where child labor is most common;

#### Social Aid

- Strongly encourages member states to take greater strides in establishing more serious punishment for hate crimes towards children;
- Condemns discrimination of all kinds against children of any gender, race, religion, sexuality, or nationality;
- 14. Endorses international foster care systems to help children to get out of situations that put them at risk.
