# Topic: The situation in Central America: progress in fashioning a region of peace, freedom, democracy and development

Deeply concerned by the violence and crime occurring as a result of a lack of education,

Concerned by the amount of violence and absence of awareness of the issues in Central America,

Deeply disturbed by the high rates of violence and corruption in Central America,

Expresses appreciation of past efforts to quell violence and to support development such as in A/RES/72/61,

Deeply concerned by the violations of human rights in the countries of Central America, Alarmed by the improper treatment of refugees in this region,

Recalling sustainable development goal 8 which aims to promote inclusive and sustainable economic growth for all,

Bearing in mind that if economy continues to decline, the cycle of poverty will spiral out of control,

#### Improvement Of Education And Funding To Combat Significant Problems

- I. Requests that member states increase funding for education;
- 2. Demands member states to provide support to those affected by environmental damage
- 3. Encourages further measures to be taken in protecting natural environments;
- 4. Calls upon member states to include content focused on eliminating discrimination and inequality in educational curriculum;

#### **Reducing Violence And Corruption**

- 5. Demands investigation on corruption within Central Americans governments via creation of unbiased and diverse committees;
- 6. Supports restrictions and certification systems such as licenses on weapon purchases;
- 7. Urges member states to collaborate to further combat drug trade in and out of Central America by expanding measures that are already in place;
- 8. Advises peacekeeping forces to be in areas of direct need in Central America;
- 9. Suggests that governments improve and reform their security and police systems in order to combat violence and the drug trade;
- Declares sanctions against gang leaders in Central America such as but not limited to freezing bank accounts and restricting travel;

#### Human Rights And Refugee Problems

- II. Requests a set of standards decided yearly by the United Nations to ensure humane conditions and resources for refugees;
- 12. Demands member states to further enforce consequences for human trafficking;
- Instructs member states to end human rights violations pertaining to female citizens within Central America;
- 14. Authorizes United Nations funds to go towards food, shelter, jobs promotion, and the creation of designated routes for refugees;
- 15. Calls for a yearly summit with representatives of the affected nations with the goal of eliminating human trafficking;

#### **Reducing Economic Problems**

- 16. Recommends evaluating the countries of Central America's resources to find a sustainable source of jobs for citizens struggling with poverty;
- Calls upon wealthier countries to invest in humanitarian aid for struggling Central American countries;
- Further requests the World Bank to provide microloans to small businesses and entrepreneurs to decrease the unemployment rate;
- 19. Demands that the minimum wage is increased to provide more stability for citizens;
- 20. Requests the creation of educational programs specifically targeted to getting citizens prepared to enter the workforce.
