# Topic: Sustainable Development - The Special Situation of Landlocked Developing Countries

Fully aware of the issues that landlocked developing countries (LLDCs) face such as no access to water and the world market,

Acknowledging that some coastal countries are not reducing import and export prices to LLDCs,

Realizes that many countries do not have access to international markets due to lack of territorial access,

Recognizing that some nations lack basic fundamental needs,

Acknowledging that LLDCs pay more to get resources,

Recognizing that people from LLDCs have to pay more for transportation,

Acknowledging that LLDCs don't have access to large bodies of water,

Alarmed by the fact that unsanitary water leads to diseases and food shortages in LLDCs,

### **Issues with Natural Resources**

- I. Requests developed coastal countries to establish trade routes in LLDCs;
- 2. Calls upon allies of LLDCs to share resources;
- 3. Encourages LLDCs to seek help from non-profit government organizations;
- 4. Urges LLDCs to create bigger protected areas to establish steady income sources from tourists;

- 5. Calls upon LLDCs to try their hardest to reduce inequalities for their people;
- 6. Expresses its hope that in future years LLDCs will be able to create cleaner energy;

### Health, Economy, and Infrastructure

- 7. Suggests developed countries to open up their borders to neighboring LLDCs for cheaper amounts of money;
- 8. Endorses developed countries to have financial meetings with more LLDCs;
- 9. Instructs countries with exceptional healthcare to send doctors to LLDCs;
- 10. Encourages countries to use cleaner energy sources;
- II. Recommends that coastal countries are aware of LLDCs;
- 12. Further requests that funding from COP27 be put to purify water in LLDCs;

## Issues with Transportation and Currency

- 13. Calls for COP27 funding to be focused on sustainable transport, infrastructure, as well as lower prices for transportation in LLDCs and transit countries;
- 14. Requests countries to exchange resources instead of purchasing them;
- 15. Further recommends countries to lower prices for LLDCs;
- 16. Strongly encourages developed countries to build canals to LLDCs with their permission;
- 17. Urges developed countries to donate funds for sustainable infrastructure;
- Strongly advises developed countries to have open borders between LLDCs and transit countries;

### **Difficulties with Water**

- 19. Emphasizes the need for trading safely;
- 20. Calls for action to climate change;
- 21. Requests that neighboring countries have their sea ports available for LLDCs;
- 22. Suggests developed countries to move funding from COP27 to help gather resources for LLDCs;
- 23. Encourages member states to share resources to create filters for clean water in LLDCs.
