# **Topic: Rights of the Child**

Deeply concerned by the amount of children facing poverty,

Bearing in mind the effect that major world wars and global pandemics have caused on the rights of the child,

Alarmed by the fact that some parents don't have the money to support their families which results in large amounts of impoverished children with a lack of education,

Deeply concerned by the amount of children lacking access to their fundamental needs,

#### Education

I. Requests better education, not only for children, but also for educators and parents

who did resist some secondary education;

2. Advises fundraising for children's homes that provide adequate education;

- Emphasizes the creation of more sports and activities for children who don't have access to better mental and physical health;
- 4. Draws the attention to the children who are unable to receive education and calls for a more affordable and accessible learning environment;
- 5. Strongly encourages the need for affordable secondary education programs;

## Funding and Donating for Families in Need

- 6. Proclaims that fundraising for children can help children in need;
- 7. Recommends the use of an online website to support orphanages, child care, and education, through donations;
- Strongly advises companies to look past wealth and appearance and, instead, base their judgment off of qualifications;
- 9. Encourages UNICEF to partner with organizations to support families in need;
- 10. Urges companies to have training programs for jobs in areas that people don't have enough experience;

# Food, Water, and Clothing for Children in Need

 Calls upon the idea of having teams that give out recyclable shoes around the globe using volunteers;

- 12. Encourages the government to lower the prices of healthcare for people below the poverty line;
- Strongly advises for governments of member states to provide financial support to those families with disabled children;
- 14. Support the idea of recycling cloth and plastic to make new clothes for the children and people in poverty;

## **Protection and Shelter for Children in Need**

- 15. Further recommends for communities to provide safe and healthy environments for those in need;
- 16. Urges governments to change minimum wage in accordance to the cost of food, clothing, and housing in their country;
- 17. Invites countries to give support to their children with disabilities who are not able to access the right care;
- Recognizes the countries that support families with children in need, and suggest that other countries follow their lead;
- 19. Suggests the creation of organizations that can assist children and families in need;
- 20. Advises countries to provide homeless shelters for families and children.
