

# **Resolution United Nations Security Council/1.1**

## **United Nations Security Council Committee**

Topic: The situation in the temporarily occupied territories of Ukraine

Noting with deep concern the issue of hunger,

Emphasizing the need for medical attention during the war,

Acknowledging the youth in Ukraine that are struggling to find education because of the war,

Affirming collaborative partnerships between countries and organizations to help provide aid of all kinds to Ukraine,

Bearing in mind that the full-scale invasion has been happening for two years,

Deeply concerned that there has been a lack of concrete solutions that facilitate peace,

Alarmed by the human rights violations caused by Russia's invasion of Ukraine,

Reaffirming Ukraine's sovereignty and the importance of upholding human rights,

#### **Humanitarian Aid and Relief**

- 1. Urges for temporary citizenship in foreign countries for those displaced;
- 2. Strongly affirms shelter will be provided following evacuation;
- 3. Supports enforcing defenses for civilians during the war;
- 4. Calls upon for transportation of medical supplies;

5. Welcomes exploring in providing cheaper physical and mental therapy to those affected by war;

### **Economic Development and Reconstruction**

- 6. Encourages displaced Ukrainians to return after the war to establish an anticorruption system;
- 7. Welcomes exploring ways to promote stability, including protection of transportation;
- 8. Directs financial aid by decreasing taxes on imported goods;
- 9. Draws attention to strengthen rule of law and establish transitional justice mechanisms;
- 10. Calls for the breaking of the blockade to allow assistance in immigration from Ukraine;

#### **Sanctions and Human Rights Violations**

- 11. Recommends situational sanctions to combat human rights violations;
- 12. Further invites the prioritization of human rights through investigators and appropriate responses such as sanctions, providing refugees shelter, and providing resources;

#### **Approaches to Peace**

- 13. Calls for a ceasefire agreement to enter into peaceful negotiations that are transparent and fair to both parties through foreign mediators and support;
- 14. Calls upon the deployment of peacekeeping missions by the UNSC;
- 15. Suggests the production of Russia and Ukraine's imports and exports through a mutual agreement limiting trade-related conflict;
- 16. Calls upon Russia and Ukraine to abide by the preexisting obligations set by their respective treaties.
