### Topic: Rights of indigenous peoples

Fulfilling basic indigenous needs will help others gain a better understanding of their country's roots and history,

Seeking help from Indigenous people will be easier if they are healthy and have a good education,

Expressing concern towards this topic,

Aware of indigenous peoples not being given equal rights and opportunities,

Aware that indigenous land is being destroyed because of pollution and war,

Noting that indigenous people are being discriminated against,

Bearing in mind that many indigenous people aren't being recognized and heard by the government,

Encouraging that all countries provide resources for indigenous people and their land,

Regretting that people are uninformed of indigenous communities and cultures,

### **Basic Needs**

1. Recognizes that the indigenous peoples need education;
2. Acknowledges that filtered water is essential;
3. Draws the attention to the need of better shelters and housing with better clothing;
4. Supports weapon restrictions in different countries;

### **Indigenous People's Rights to Land And Protection**

5. Urges member states to support developing countries to end civil wars affecting indigenous group's land;
6. Urges that countries should educate youth and adults to help prevent indigenous discrimination;
7. Advises member states to set limits on reducing resources taken from indigenous land;
8. Encourages countries to reserve land from a distance of urbanization for indigenous people without interference of other civilizations;
9. Encourages indigenous people to keep a safe distance from urbanization to keep their culture;
10. Calls upon the reduction of urbanization on indigenous land;
11. Further recommends that countries stop polluting indigenous land and resources;

### **Maintaining Their Position in the Government**

12. Encourages conventions and meetings to be hosted periodically to give all indigenous peoples the opportunity to have their voices heard by government officials;
13. Encourages governments to provide healthcare for indigenous people;
14. Further recommends member states to have charity events for indigenous peoples and put funds into healthcare for indigenous people;
15. Strongly encourages member states to consider putting indigenous people in their government that have decent education;
16. Calls upon countries to be aware of where indigenous people live not to tear down their cultures and homes;
17. Encourages the governments of member states to create online resources to teach about the indigenous people;

## **Equal Rights and Opportunities**

18. Emphasizes the need for all children and adults to get opportunities at local schools, education centers, and workplaces;
19. Requests governments to create more job opportunities for indigenous people, while keeping their culture;
20. Reminds that everyone has the right to vote;
21. Advises that more shelter and housing in urbanized and rural areas is provided for indigenous peoples;
22. Emphasizes that everyone should have the same dignity and rights.
