### Topic: Disaster Risk Reduction

Alarmed by the lack of funding towards Disaster Risk Reduction (DRR) impacts an affected country's economic state,

Deeply concerned that due to the lack of good infrastructure, structures need to be rebuilt after disasters,

Seeking research on the cause of natural disasters to ensure an improvement in safety,

Alarmed by the lack of preparedness and education about natural disasters,

Encourages appropriate action to be taken regarding the loss of power in communities caused by calamities,

Expressing concern about the consequences of natural disasters in countries,

Alarmed by the economic impacts caused by natural disasters,

Taking into consideration the mental and physical damage dealt by natural disasters to citizens,

Aware of nutritional deficiencies caused by food shortages in the aftermath of natural disasters,

Aware that food shortages and nutritional deficiencies contribute to the endangerment of life,

Bearing in mind the lack of emergency systems,

Having examined the infrastructures of the vulnerable areas,

Keeping in mind the importance of the proper use of resources,

## **Preparedness**

1. Urges developed countries to provide funding for less developed delegations;
2. Supports the sharing of research and data to create solutions;
3. Calls for the successful implementation of the Sendai Framework;
4. Invites developed countries to share research and data about natural disasters to less developed countries;
5. Recognizes the importance of 3D printed homes with good infrastructure against natural disasters;

## **Aftermath of Natural Disasters**

6. Draws the attention towards the lack of housing and the displacement of civilians as a result of natural disasters;
7. Further proclaims the importance of tackling food insecurity;
8. Encourages appropriate action to be taken regarding the loss of power in communities caused by calamities;
9. Supports everyone who got offended by the disaster;
10. Urges the government and the media to bring and raise awareness towards the losses brought by disasters;
11. Alarmed by the inefficiency of past recovery efforts after earthquakes, tsunamis, fires, etc.;
12. Calls upon proper assessment of damages in affected areas;

## **The Endangerment of Human and Animal Life**

13. Calls upon member states to conserve natural reserves for animals and humans in the emergency of a natural disaster;
14. Authorizes deployment of international rescue groups that answer international emergencies;
15. Demands the use of space technologies to direct natural disasters;

## **During a Disaster**

16. Further recommends the creation of highly developed emergency systems to alert the citizens about evacuation during disasters;
17. Urges the financial collaboration of all nations to monetize those emergency systems;

18. Demands to do an annual examination and registration of the infrastructure of vulnerable areas by a special commission from the government of each country;
19. Strongly encourages the United Nations Disaster Risk Reduction Organisation in case of natural disasters to finance the creation of buildings that are deteriorating;
20. Considers the importance of structures well prepared with basic needs to become temporary houses in case of disaster.
