Topic: Corporate environmental responsibility

Deeply disturbed by the harmful effects of corporate negligence on everyday life and the environment,

Aware of corporations overlooking their environmental effects regarding poverty, disease, deforestation, mass pollution, and waste,

Alarmed by the lack of awareness of corporate responsibility,

Recognizing the ignorance towards environmental goals and corporate usage of sustainable resources,

Noting with deep concern the lack of public pressure,

Deeply regretting the human role in the creation of the hole in the ozone layer,

Aware of greenhouse gas emissions caused by corporations and their significant effects on air and water quality,

Fully alarmed by the amount of fossil fuels burned each year,

Transparency

- I. Calls upon schools to teach more about environmental responsibility;
- 2. Recommends influencers to raise awareness about misinformation in companies;
- 3. Encourages stricter guidelines to be made for companies to follow;
- 4. Further requests the implementation of environmental goals;
- 5. Draws attention to the ignorance of corporations and their use of sustainable resources;
- 6. Introduces the possibility of an NGO that helps developing countries tackle this issue;

Emissions

- 7. Calls upon countries to decrease the amount of fossil fuels burned by utilizing sustainable alternatives;
- 8. Recommends countries to remove excess CO2 using carbon sinks by putting CO2 in the ground;
- 9. Further requests countries to utilize their resources to create sustainable and clean energy, such as solar panels and hydroelectric power;

Repercussions of Corporate Actions

- 10. Advocates that countries establish regulations on what corporations can do regarding deforestation and their carbon outputs;
- II. Advises companies to use sustainably sourced materials and eco-friendly development practices;
- 12. Calls upon the media to hold corporations accountable for their actions;

13. Recommends addressing these issues by implementing CER policies, educating corporations on their impacts on the environment, and providing incentives for corporations to have a positive effect on the environment;
