Topic: Green cities

Noting with approval all measures taken to reduce environmental isssues,

Sustainable Urban Change in Energy

- 1. Calls upon member states to take action against climate change and pollution;
- 2. Encourages community members to participate in the reduction of waste;
- 3. Requests funding for impoverished countries to protect against environmental issues;

Urban Growth Infrastructure and Quality of Living

4. Encourages member states to offer tax cuts to cities with outstanding green infrastructure programs;

- 5. Emphasizes the need for member States to provide affordables and sustainable housing to citizens by repurposing unused or abandoned infrastructure;
- 6. Expresses its hope for countries to promote the management of sanitation;

Environmental Issues

- 7. Encourages countries to support others if needed;
- 8. Calls for an increase of vegetation protection;
- 9. Encourages vertical greening and roof greening;
- 10. Calls for protection of biodiversity;
- 11. Promotes the reintroduction of species to achieve ecological balance
- 12. Encourages the establishment of logical legal institutions;
- 13. Encourages member states to offer tax cuts to cities with outstanding green infrastructure programs;
- 14. Emphasizes the need for member states to provide affordable and sustainable housing to citizens by repurposing unused or abandoned infrastructure;
- 15. Expresses its hope for countries to promote the management of Sanitation;
- 16. Requests that member states and NGOs provide access to education on health, fossil fuels, and emissions for citizens;
- 17. Requests cities to attend to waste management for a more clean and sustainable city;

Agriculture and the Environment

- 18. Encourages member states to promote consumer supported agriculture globally;
- 19. Calls for all to assist in the creation of green spaces by planting greenery in proximity of urban spaces;
- 20. Advises centralizing local produce in food supply;
- 21. Endorses tax cuts for businesses with green spaces;
- 22. Invites governments to condemn the large scale use of pesticides.
