Topic: Corporate environmental responsibility

Alarmed by rising global temperatures and sea levels,

Concerned by the impact corporations have on the environment,

Reaffirming the need for global cooperation to achieve Sustainable Development Goal 13,

Recognizing that governments, international organizations, civil society, and consumers have an important role in promoting businesses to fulfill environmental responsibilities,

Recognizing the need for a workforce to reduce carbon dioxide emissions and pollution deforestation,

Acknowledging the production of green cities can help reduce greenhouse gas emissions from corporations,

Recognizing the positive impact of a carbon tax on corporate responsibility,

Emphasizing eco-friendly engineering in modern society,

Keeping in mind the responsibilities of corporations to preserve the environment and use clean and renewable energy,

Affirming the need for stricter laws and regulations regarding clean energy and the environment,

Realizing the need for educated employees and leaders,

Renewable and Clean Energy

1. Encourages that renewable energy needs to be taken advantage of to help reduce carbon footprint;
2. Notes that corporations are investing in eco-friendly engineering to help ecologically unstable countries;
3. Noting all forms of energy are wasted, especially water;
4. Introduces reliable, renewable energy forms that push for a more sustainable future;

Corporate Accountability

5. Encourages member states to impose fines on corporations that are noncompliant with climate regulations;
6. Urges hiring more environmentally reliable employees;
7. Suggests member states and corporations to reduce waste and their carbon footprints;
8. Emphasizes the necessity of government intervention in gas emissions from continuous corporate offenders;

Solutions Regarding Sustainable Development

9. Encourages sustainable alternatives to single-use plastics that reduce waste and littering;
10. Appreciates the institutionalization of corporate environmental responsibility in all corporations, especially those related to food and agriculture;
11. Calls for the reduction of pesticides, fossil fuels, and waste of all kinds;
12. Appeals to the need for clean energy programs, such as E-buses electric cars, and more;
13. Welcomes innovations regarding environmental sustainability;
14. Encourages governments to support businesses in transitioning to eco-friendly agriculture through policy incentives such as tax benefits, subsidies, and green finances;

Encouraging Global Cooperation

15. Urges member states to meet regionally to discuss corporations' impacts on the environment;
16. Calls for the creation of a new United Nations body to regulate greenhouse gas emissions created by major corporations;
17. Encourages education of the public through the use of corporate programs regarding companies' negative effects on rising global temperatures;
18. Underlines the importance of directing government funding towards eco-friendly corporations and initiatives.
