### Topic: Pandemic preparedness and response

Acknowledging the social gap created due to isolation and lack of communication during the COVID-19 pandemic,

Recognizing the importance of sharing information and data about disease between countries,

Aware of the lack of education around pandemic preparedness,

Recognizing socioeconomic policies addressing citizens' needs are necessary precursors for the effectivity of lockdown measures,

Recognizing the importance of early detection regarding pandemics, as well as acknowledging existing vaccination and health protocols,

Deeply convinced of the need to implement technological advancements regarding pandemic preparedness and medical obstacles,

### Resources and Technology

1. Requests member states to apply successful strategies from past pandemics to better combat and prevent future pandemics;
2. Emphasizes the importance of quick transportation times of medical supplies and professionals to contain the spread of pandemics by the use of mobile clinics and medical trailers;
3. Urges Member States to provide funds and resources to other Member States;

## **Pandemic Education and Information**

4. Calls upon Member States with a surplus of resources to aid other countries in order to improve infrastructure and research;
5. Strongly encourages the research of diseases to stop pandemics from spreading;
6. Urges Member States to improve the spread of education concerning pandemic preparedness;

## **Mitigating the Socioeconomic Effects of Pandemics**

7. Advises governments to assist vulnerable populations (unemployed, elderly, impoverished) through distribution of subsidies, grants, and insurance;
8. Suggests the implementation of de-centralized/regional community care centers, food/water/shelter and other necessity programs;
9. Advises member states to establish a global advisory board comprised of experts and civil leaders to recommend evidence-based health measures
10. Recommends the improvement of fact-checked online platforms for social and government communication needs channels;

## **Facilities and Protocols**

11. Encourages Member States to implement a global support system for healthcare, including a pandemic preparation system, quarantine protocols, and a national disease monitoring system;
12. Urges Member States to implement pandemic-specified wings to already existing care facilities inside and outside places of conflict;
13. Requests Member States to apply successful strategies from past pandemics to better combat and prevent future pandemics;
14. Invites Member States to agree upon the NET (Nurture/Necessity, Evidence, Technology) global safety net framework, encouraging policies to fulfill citizens' needs to be backed by evidence and utilize innovative technology.
