#### Topic: Universal health coverage

Acknowledging the lack of accessibility of; infrastructure, staff, and resources due to low funds,

Draws attention to unaffordability of healthcare, and the costs of insurance budgets, especially in rural areas,

Recognizing the lack of proper medical services due to insufficient communication between governments, healthcare systems, and insufficient funding,

Recognizes that hospitals need expansion,

Fully aware that medical transport should be more accessible,

Recognizes that healthcare workers need proper training for universal healthcare goals,

Desiring easier and more affordable ways to get healthcare,

Further believing the need to educate on healthcare services due to the lack of resources,

#### Healthcare cost and accessibility

1. Calls upon wealthier membered states with more resources to offer medical support to less developed countries;
2. Supports government funded medical institutions;
3. Encourages the collaboration of underdeveloped countries in order to provide quality healthcare;
4. Advises member states to supply more financially accessible medical transportation;
5. Strongly encourages limiting prices on insurances, healthcare bills, prescription medication and further issues;

#### Global health equity

6. Urges the member states of the UN to invest in improving healthcare infrastructure; .
7. Encourages government funded education for medical students;.
8. Calls upon further developed countries to support developing nations surrounding healthcare and finance;
9. Further invites nations to eradicate the lack of communication between healthcare providers through summits and regular check-ins;

#### **Building healthcare institutions and distributing healthcare to all**

10. Invites countries to seek a more affordable healthcare plan;
11. Calls upon countries to make medical services more accessible;
12. Encourages other countries to help each other with health services;
13. Endorses the manufacturing and distributions of vaccines;
14. Acknowledges that more healthcare institutions should be expanded and built, especially in rural areas;

#### **Easier access to medicine and healthcare**

15. Strongly recommends for check ups to be free and mandatory;
16. Encourages easier access to prescription medicines;
17. Calls for stronger clinical practice guidelines;
18. Urges for improvement of working conditions for medical professionals;
19. Urges an increase of healthcare workers;
20. Strongly encourages countries to adopt a health plan that will suit them best;
21. Further reminds countries to support rural communities with healthcare.
