Topic: Right to food

Emphasizing the poor living conditions for farmers,

Noting with regret that food is harder to grow when water is scarce,

Fully aware of the fragile balance between water scarcity and water overconsumption,

Taking note that population growth can create a larger need for water and food,

Considering the use of food kits and rooftop gardens,

Deeply concerned of how climate change affects crops by causing floods and other natural disasters,

Acknowledging that climate change has gotten worse over the years,

Alarmed by the amount of carbon emissions,

Deeply concerned about the amount of pesticides used,

Farmers and Farmland

- I. Requests more funding for modern farming tools;
- 2. Strongly encourages to educate farmers on water usage and its effects on crops;
- 3. Recommends farming near water instead of bringing water to farms;
- 4. Strongly encourages not to waste fundamental needs like food and water by participating in activities such as composting;

- 5. Calls upon other countries and member states to create more organizations to preserve food and water;
- 6. Requests better water consumption metrics on farms;

Food Insecurity Related to Water

- 7. Urges states to protect crops from natural disasters;
- 8. Invites member states to push for more action on food security;
- 9. Congratulates governments actively working towards food security;
- 10. Recommends water purification systems to improve agricultural production;
- II. Urges people to conserve more water for food and crops;
- 12. Authorizes redirection of government funding to water conservation and food security operations;

The Use of Pesticides in Food Production

- 13. Calls upon member states to reduce the production of harmful pesticides;
- 14. Strongly encourages ethical, sustainable, and developmental ways of producing crops;
- 15. Supports organic farms;
- 16. Encourages adopting new eco-friendly farming practices;
- 17. Recommends farms to use nitrogen-inducing crops;
- 18. Draws the attention to pesticides being harmful to flora and fauna;
- 19. Invites more farmers to go organic;

Food Insecurity Related to Weather

- 20. Further encourages member states to adopt a resolution that slows climate change and resolves global warming;
- 21. Requests harvesting rainwater to save food for droughts;
- 22. Urges farmers to use fuel-efficient equipment;
- 23. Calls upon preparation before natural disasters;
- 24. Endorses the use of modern, sustainable farming methods to minimize waste.
