#### **Topic: Women's meaningful participation in peace processes**

Deeply concerned that men are not respecting women's jobs,

Alarmed by the fact that men think women can't do the jobs they do for not being strong or manly enough,

Acknowledging that women are not being heard,

Keeping in mind that women do not always have the same opportunities that men have,

Deeply regretting women not being included in peace processes even though deals last longer when women are part of the talks,

Taking note of women's defense as an act of protection,

Deeply regretting to not have done anything about the current situation,

Acknowledges that females aren't often included in many of the peace processes,

Alarmed by the fact that women aren't included in certain empowerment classes that they deserve,

#### **Involving women in empowerment groups**

1. Encourages women to take self defense classes to protect themselves;
2. Acknowledges that women need to have a safe place to go when they are being harassed;
3. Suggests men to help women to eliminate abuse;

4. Directs men to look from a different angle at abuse towards women;
5. Further reminds that women have the right to protect themselves without any harm or cost if others harm them;
6. Introduces to the world that this is a major problem that needs to be solved and spoken about;
7. Trust that the UN will bring this up during important discussions;

### **Women's defensive actions**

8. Encourages nations to accept women into leadership roles;
9. Regrets to inform countries that  $\frac{2}{3}$  of women don't get the opportunity to become empowered;
10. Draws attention to the fact that the UN should encourage governments to add more women empowerment groups;
11. Suggest women to start in small roles and go bigger over time to show men how they do in those positions;
12. Calls for the entire world to listen and act on the problem of not including women in empowerment groups;
13. Notes that empowerment groups are very important to women's social well being;

### **Respecting women's jobs**

14. Advises men to accept women into the workforce;
15. Further requests that the UN help fund for women in jobs;
16. Calls for women to have higher placement jobs
17. Further recommends that women get the same amount of pay as men;
18. Urges that women stand up for themselves and for other women in the workplace if they are being mistreated;
19. Trusts men to respect women while working or just day to day tasks;

### **Empowering other women**

20. Urges countries to partner with other countries to make sure women can participate in peace processes;
21. Encourages women to empower other women;

22. Further invites that one gender of peace negotiations do not exceed 60%, and not below 30%;
23. Encourages women leaders that they should empower other women and make them feel confident;
24. Urges peace negotiators to include civilian groups, such as the ones women have founded;
25. Calls upon women to speak up in peace processes and justice;
26. Suggests training where there is conflict to train women to become leaders.
